

Each year, Terri selects a community service project


to participate in, and for 2015, she has chosen the Red Scarf Project.

## Jim and Carody Wise Share a Legacy Devoted to Helping Others Hear Their Best

#### **Humble Beginnings**

Nearly 30 years ago in 1985 when Jim Wise, Ph.D., FAAA, and his wife, Carody, started Associated Audiologists, they had no idea the impact the practice would have on the lives of thousands of area residents in need of hearing healthcare, and their families.

"Our first office was literally a closet inside the volunteer office at Olathe Medical Center," Dr. Wise recalls. "It was a very humble beginning."

Carody remembers calling him every day. "I would check in to see if anyone had

scheduled an appointment. We were just waiting for the phone to ring."

Fortunately, it didn't take long for word to spread that Associated Audiologists was a professional, quality, comprehensive practice dedicated to providing hearing healthcare to patients of all ages. "I was inspired by my father's background as a pediatrician to pursue a career in audiology and have worked over the years to elevate the status of this field to that of a medical professional," Dr. Wise says.

#### **Growing Strong**

By 1989, the practice had added its second location in Prairie Village. A decade later, in 1999, the practice's third office in Overland Park at Saint Luke's South opened. In 2008, the practice added a Leavenworth office, and relocated its Olathe office to the campus of Shawnee Mission Medical Center. Tim Steele, Ph.D., FAAA, and his wife, Julie, purchased the practice from Dr. Wise and Carody in 2010, beginning the transition in ownership.

Dr. Wise and Carody remained involved in the practice as it continued to grow. Many changes have taken place during this time including the relocation of the Shawnee Mission office in 2011 to the Antioch Hills Medical Building; the addition of a clinic in Manhattan, Kan., in 2012; the relocation of the Overland Park office to the Southridge Medical Building in 2012; and the opening of the practice's newest location in the Northland in October 2014.


Over the years, the practice has grown from just Dr. Wise to 15 university-trained audiologists. Carody, a certified public accountant, has served as the practice's chief financial officer and administrator. Today, Dr. Steele is the practice president, and his wife, Julie, is director of operations. They are supported by a dozen administrative team members who serve nearly 34,000 patients.

#### A Family Endeavor

When Dr. Steele completed his clinical fellowship with the practice, Dr. Wise sensed he would be a good "fit" for Associated Audiologists. "Tim has all the qualities necessary to lead the practice going forward—his fortitude, entrepreneurial spirit and commitment to family made Tim and Julie our first choice as we considered a transition in ownership," Dr. Wise says. Carody agrees, "Because Associated Audiologists is such a family endeavor, it was almost like our family chose their family."

"Dr. Wise served as my teacher, friend and mentor," Dr. Steele says. "He established the highly-professional, yet caring atmosphere

Associated Audiologists is known for, and our goal is to continue to deliver the high level of personal service and care our patients have come to expect."

### Community and Professional Service

Throughout his career, Dr. Wise and Carody have believed strongly in community service. Dr. Wise participated in a medical mission trip to India, where he met and was blessed by Mother Teresa. He later participated in a medical mission trip to Jamaica.

He is a long-time member of the Olathe Rotary Club and a three-time recipient of the Paul Harris Fellow Award. Dr. Wise helped found the Kansas City Chapter of Self Help for Hard of Hearing, now called the Hearing Loss Association of America. He has also maintained a long-standing association with the Kansas School for the Deaf in Olathe and has served as a board member of the Foundation on Aging and an advisory board member of Aberdeen Village.

He has served as president of the Kansas Speech and Hearing Association and received the group's "Honors of the Association." He was president of the Kansas Commission for the Deaf and Hard of Hearing. He also worked with other professionals in the state of Kansas to pass legislation for the early identification of hearing loss in infants. This resulted in the state's requirement that all newborns be screened for hearing loss at birth and before being released from the hospital.



#### Plans for the Future

Reflecting on his 40-year career in audiology, Dr. Wise says, "The field has changed dramatically. The level of expertise, scope of practice and technology necessary to practice today have made great advancements."

Still, he believes the business principles that guide the practice remain unchanged. "What's most important is to do the right thing for the patient," he says. "Our audiologists are passionate about helping others."

Following their retirement in late November, Dr. Wise and Carody look forward to spending more time with family, including their daughter, Sally, and son, Ben. They also hope to travel, golf and fly fish. "We'll have more time and energy for the Mission Project, a not-for-profit supporting independent living for individuals with developmental disabilities, including our son Ben, who has Down syndrome," Dr. Wise says.

"We thank Dr. Wise for the firm foundation that he built Associated Audiologists on," Dr. Steele says. "We will greatly miss him and his dedication to his patients and our profession, and we wish Jim and Carody our best in all they do."

"We have truly been blessed with wonderful relationships with

our patients and their families, our staff and their families, and the many long-term advisors we have worked with through the years as we have built the practice," Dr. Wise says.

"This has been a tremendous journey. I have shared my life with many of you, just as you have shared your life with me. Your stories have inspired me and your friendship has kept me going all these years. They are treasures dear to my heart and the essence of time well spent. Carody and I will miss the practice, our staff and all of you, but we are confident you are in good hands with Associated Audiologists."




Clinic Manager, recently traveled to Guatemala to train nurses, teachers and community leaders to perform hearing screenings.

#### **CLINIC CORNER**

#### Question:

When I put my finger in the ear canal when wearing my hearing aid, why do I seem to hear more?

#### Answer:

Many of our patients wear open-fit hearing aids, where the ear canal is unblocked. This intentional strategy allows the low frequency, or bass sounds, to pass naturally into the ear canal with little amplification based upon the configuration of hearing loss. If you use a custom earmold, a vent is utilized to allow air passage and also for low frequencies to pass, similar to an open fitting. Venting and open-fitting strategies also assist in preventing occlusion, improving the comfort and naturalness of one's own voice and alleviating the negative effects from chewing and eating.

When an individual puts their finger up to the ear canal and either blocks the ear canal or the vent in the earmold, this "holds" the low-frequency sounds in the ear canal, creating a temporary increase in perceived volume. Even though this does create the perception of increased volume, it isn't necessarily best for the needs of the hearing loss or the overall quality needs of sound for the individual.

Is there a difference between a hearing aid program/plan and a hearing aid benefit?





**Yes.** A hearing aid program or plan through your health insurance uses a third party to promote specific products or providers. In most cases, you can still choose who you prefer to work with if they accept your insurance.

A hearing aid benefit is health insurance coverage that helps pay for all or some portion of a hearing aid purchase. Some insurance plans provide hearing aid coverage, but many do not.

You also should be aware that if you schedule a hearing evaluation before the end of 2014, you may be able to take advantage of insurance deductibles, if you have met yours for the year.

At Associated Audiologists, we accept most major insurance plans including Blue Cross and Blue Shield, United Healthcare, Aetna, Cigna, Humana, Coventry, Tri-Care, and many others.
